Castell explained the financial challenges the Association is facing. A motion was made and seconded to ratify the Board adopted 2010 Budget. MSI, LLC distributed ballots for the motion. The results of the Delegate votes cast were as follows:

A total of 378 Delegate votes were cast to approve ratifying the Board adopted 2010 Budget and 363 Delegate votes were cast to reject it. Since a majority of the Delegate votes were cast to approve ratification of the Board adopted 2010 Budget, the Budget was ratified.

- Issue: Ridgewood Hills Master Association 2010 Budget Ratification
 - Discussion/Summary: The Board adopted 2010 Budget was discussed by the Delegates and Board members in attendance. A motion was made and seconded to ratify the Board adopted 2010 Budget. MSI, LLC distributed ballots for the motion. The results of the Delegate votes cast were as follows:

A total of 207 Delegate votes were cast to approve ratifying the Board adopted 2010 Budget and 534 Delegate votes were cast to reject it. Since a majority of the Delegate votes were cast to reject ratification of the Board adopted 2010 Budget, the Budget was not ratified. As a result, the 2009 Budget, which was ratified on November 25, 2008, will continue into 2010.
